

Wintertime Cabin Visits

When the snows arrive and blanket our hillside, Mother Nature enforces a very different set of rules than we are familiar with in warmer months. Those of us, who choose to accept her terms and make winter visits to our cabins, owe it to our community to conduct ourselves in a way that causes the least amount of disturbance for our fellow residents. To make that happen requires some hefty doses of both understanding and planning.

It is essential to know that the snow cover makes everything more difficult and take longer to accomplish. Nightfall further complicates the daytime's difficulties, as well as creating its own



cabin in hopes that you will encounter favorable conditions, or that someone will be available, or willing to help you when things don't go well upon your midnight arrival, is not a recipe for success or enjoyment.

It's only natural to hope for the best, but the wise will also plan for the worst. If you are arriving late, you might be well advised to spend the night in a local motel, then attempt to reach your cabin the following morning.

set of problems. In addition, the winter days are short. Near the winter solstice, our mountain is cloaked in darkness by 5:00 P. M. -- even earlier if heavy overcast is present.

Having a well thought out strategy for reaching the Moreno Valley, then getting to your cabin, and then getting all your cargo unloaded and inside, is a must. Jumping into your vehicle and blasting off for your



Did you arrange for snow removal from your road, or driveway, or intended parking spot before leaving home? If not, your chances could be bleak. Even if you did, it may have snowed, or blown and drifted during your travel time. To my knowledge, our residents have established contacts with four local individuals who are willing to do snow removal.

Their contact information can be found on Idlewild's website, www.idlewildcommunity.org. Click on the header "Contractors Service Providers" which will display information for snow removal services and much more.

Unless you are very lucky, it is almost certain at some point that your vehicle will lose traction and you will find yourself against something immovable, or that one of your wheels is buried in the deep stuff. Expect it and be prepared. Do not let yourself be completely dependant upon someone else to get you out of your jam.

Then, there is the weather itself. As we all know, it matters very little what the Tulsa, or Seattle, or Indianapolis, or even Albuquerque television station says the forecast for north-central New Mexico will be. Our mountains make their own weather. It's even more true in the winter, which makes it all the more necessary to be flexible and adaptable.

Along with having a good understanding of winter's unique challenges, plus a solid plan to deal with those challenges, a wintertime visitor should be as self-sufficient as possible. Be prepared to manage your own mishaps.

Allow me to wear my Road Committee hat and my Board of Directors hat simultaneously for a moment in order to address a few points and clarify some others.

The I. W. C. C. Board of Directors has not made any arrangement

with Frank Dodge or the Hatfield's to handle snow removal for individual property owners. The Board did enter into an agreement to pay the Hatfield's an hourly rate for the use of their tractor, with Frank Dodge serving as the operator. The sole purpose of this agreement is the maintenance of community roads in an effort to minimize the need for an outside contractor.

If you have been unclear about the nature of the I. W. C. C. agreement, and if you have used Mr. Dodge and the Hatfield's tractor for snow removal, you may want to consult with Mr. Dodge or one of the Hatfield's to assure you are not indebted to someone.

Be understanding of the fact that our caretaker cannot accommodate all the requests he receives for individual assistance. This circumstance is magnified in the winter when, even though there are very few of us present, our needs are greater and more urgent because of the conditions.

As mentioned earlier, the cabin owner's best assurance of an enjoyable wintertime visit is the ability to resolve his or her own problems.

Allow me to remind all of us that I. W. C. C. has never put anything in the caretaker's responsibilities that directs him to perform tasks for individual property owners. If Frank Dodge has assisted you with your personal projects, he has done so at his own initiative and does not receive any form of payment from I. W. C. C. for his efforts.

As long as there is a Highway 127, it will likely be a problem in one-way, or another. In mid-winter it is flanked on either side by high banks of snow created by the activity of the snowplows. It is nothing unusual for the wind to blow and drift snow back into the driving lane shortly after the plowing is completed. Thereby, stranding residents either in, or out, of our community.

In late winter and spring, Highway 127 becomes a series of mud bogs. It is passable when it is frozen, but during the warmth of the day it's a roll of the dice. Another issue is parking your car along the highway. For your own sake and the consideration of others who may be in the community, make absolutely certain other vehicles can get by yours. Remember that the snowplows are over-width. Their priority is to plow the road, which they will do, then leave you to deal with the consequences.

If the difficulties and uncertainties of Highway 127 are problematic for you, give some serious thought to the wisdom of making a winter trip to your cabin. If you are on a tight schedule and the highway closes, there simply is no way to remedy the situation. A possible solution might be to leave a vehicle somewhere in Eagle Nest. It is almost always possible to walk or snowmobile to town.

Above all, have the utmost respect for the property of other community residents. One of the real curses of wintertime visits is that the conditions just seem to make things go wrong. As careful as we may be, there is still plenty of opportunity for misfortune and adversity. I can't explain why, I just know from experience that's how the winter is.

If you find yourself in a predicament whereby you cause damage to something of your own, sorry for your bad luck. If it becomes unavoidable that you damage something of your neighbor's, uphold your responsibilities to the damaged party.

As more and more of us seek to use our cabins in all four seasons, the challenges of winter visitation will become more apparent and better understood. With some forethought and preparation, increased winter visitation does not have to be accompanied by frustration, distress and disappointment.

President Don Woolsey called the meeting to order and opened with a prayer.

Board Members present and introduced were A.J. Beretta, Sue Dorr, Jim Herman, Chris Herring, Mark Jefferson, Ann Knupp, Jerry Middleton, Don Reavis, Jerry Thomason, Ron Wells and Don Woolsey. (Lisa Henthom arrived from Colorado Springs as soon as possible.)

Ron Wells moved to accept the minutes of the July 2008 meeting as published. Jerry Middleton seconded. Motion passed.

A.J. Beretta presented and explained the Treasurer's Report. Dot Wells moved to accept the report. Mary Lib Thomhill seconded. Motion passed. (Financial Report attached.)

Frank Dodge, Caretaker, thanked the community for the new house.

Joe Stehling of Hidden Lake discussed Fire Wise and safety issues.

The topic of unleashed dogs running loose was discussed. Members were told to call the sheriff if they have a problem. The county law says dogs must be on a 6 foot leashed being controlled by an adult.

A Caretaker Cabin Committee was formed. Chris Herring will chair the committee.

The Preacher Cabin needs refurbishing. Jerry Thomason will be in charge of the repairs.

Jim Herman reported on the Road Committee. Work has been done. There is a trouble spot on Road 4

Jim Herman reported on the Idlewild website. The website has been updated. Craig Sutton is the web master.

Mark Jefferson reported on the Property Committee. The Kaye's property deal has been completed and the Kaye's made a generous donation to the Eagle Nest Volunteer Fire Department to help with buying an RTV. Jan Clay's request to buy lots is in the works. The form requesting to buy lots has 90 days to be finished. Mark continues to work with Glen Raef concerning IWCC buying his lots adjacent to the Worship Center.

Mary Lib Thomhill reported on the Beautification Committee. The only problem is the "swimming pool" on Road 9. Jim Herman is pursuing the problem.

A.J. Beretta reported on the Forest Safety Committee. Idlewild needs an escape plan in the event of a forest fire. The developed plan will hopefully be in the newsletter. The Eagle Nest Volunteer Fire Department is accepting donations for a Polaris Ranger 6x6 (RTV), which is much needed for rough terrain. Don Woolsey said that in discussing the issue with the fire department, there was talk of putting in a water holding tank on IWCC property.

Sue Dorr reported on the Property Rental Committee. The guidelines are posted on the bulletin board at the Worship Center.

Ann Knupp reported Ron and Dot Wells will format the cabin histories.

Mark Jefferson asked that articles for the newsletter be sent to Sandy Jefferson.

Donna Porter was thanked for her wonderful job with the Worship Committee. Theo Houser asked for a vote on whether all should be introduced at the worship services. The vote was no, although it is for the worship leader each Sunday to decide.

Frank Dodge gave the Caretaker Report. Frank said he enjoyed being the caretaker. Frank was thanked for the good job he continues to do for Idlewild.

New Business

The necessity for having dogs on leashes will be put on the website.

The Board of Directors recommends that the annual dues be raised from \$150 to \$200. Theo Houser so moved. Dot Wells seconded. The motion passed.

Don Woolsey reported on the survey of IWCC boundaries, which was done by Bill Masher. Six border points were established. David Hamilton explained the survey.

Jim Herman reported on the Nominating Committee. His committee included Wana Castleberry and Jerry Porter. Sue Dorr, Jerry Middleton, Donna Porter and Ann Knupp were nominated for the Board of Directors. Theo Houser moved to accept the slate by acclamation. Chris Herring seconded. Motion passed.

Lisa Henthorn thanked Jim Herman for all the work he has done for the community. He was applauded. Lisa also said she was sorry the calendar was late this year due to the hurricane which wrecked her house.

Ron Wells, Pot Luck Lunch Chairman, thanked all who helped. Ron was thanked for all his efforts in making the Pot Luck Lunch a success.

The next Annual Meeting will be July 25, 2010.

The meeting was adjourned.
