## Forest Health & Safety

Frank Ray, Chair, A.J. Beretta, Kala Marsh, Frank Dodge (ex-officio)

We welcome Kala Marsh to the Forest Health and Safety Committee. Kala's family, the Crawfords, are long-time cabin owners at 22 Road 4.

The IWCC, through action by the Board of Directors continues to maintain a committee regarding forest health and safety (FH&S).

Forest health is greatly affected by the presence of cabins, septic tanks, automobiles, water

wells, and the needs of residents. Forest safety can be sharply lessened by careless or negligent human activity.

The Greater Idlewild community is mostly a sparsely visited summer retreat where we can regenerate our life energies, get reacquainted with a simpler and more natural environment, escape the summer heat of lower elevations, and join our mountain friends again. Because we are not a community in the sense of constant presence and maintenance, it is more difficult for us to pay attention to our collective relationship to the forest and our impact upon it. Photos from the 1930s and 1940s show clearly how densely forested the area has become since the last timber harvest. Now that there are 237 cabins dotting the landscape, timber harvest in the commercial sense is no longer viable, and tree removal for any reason has become much more technical and hazardous.

Other communities in the Moreno Valley that have less housing density and more constant habitation, have dealt more rigorously with FH&S issues common to any wildlife-urban-interface (WUI) community, with state support, have been able to set up the guidelines known collectively as "Firewise" practices. These are typically communities with multi-acre lots have been established since about 1990. Major participants in the local Fire wise Coalition are Cimarron, Elk Ridge, Taos Pines, Ute Park, Vermejo Park, and Hidden Lake. Several of

the Coalition communities recently were awarded a \$300,000 Hazardous Fuels Mitigation Grant for thinning and chipping, an example of support that is available to dedicated Firewise groups.

The practice of developing land in the 1930s, when the J.W. Dickerson and Donel Heights subdivisions were platted, did not include proper consideration of forest health and safety, but was intended as a means to sell vacation home lots. Fortunately, over many years, most of the residents who have built in the Greater Idlewild area, the Dickerson and Donel Heights subdivisions, and the approximately 65 adjoining free plots adjoining, have individually taken care to purchase enough land to allow a more reasonable approach to WUI living, but compared to modern standards, the Idlewild community is more akin to an urban neighborhood than it is to the current typical Fire wise Coalition settlement, where properties have much more breathing room.

In Idlewild, we can however take many of the Fire wise practices to heart, discuss the various forest issues with our immediate neighbors, and take positive steps toward minimizing fire danger and promoting forest health in a local fashion. Every small step taken in this way will help the overall situation.

Some points of action to consider:

### 1. CLEARING AND CHIPPING.

At the last annual meeting Don Woolsey said that he was aware that Colfax county owns a large wood chipper that is available for communities in the county. A.J. recalls that he said that there was no charge. The county would provide the chipper and one worker to communities that would provide helpers and have wood to chip. If there is interest from residents in IWCC to make their properties more firewise next Spring and summer we could schedule the chipper next August or whenever desired to go through the community and chip the slash piles made by residents cleaning their properties.

### 2. EVACUATION PLAN

A request was made last year (2008) by the Board of Directors that the Forest Health & Safety committee develop a map for publishing in the newsletter that would show various escape routes in the event of a wildfire, using various fire location scenarios. These maps could be posted in cabins

like they do in motels showing fire escape routes. It could be developed further with a brief list of what to do before leaving i.e. take money, medicines, cell phones, etc. and the more obvious like getting everyone out, including pets if time permits.

Meetings in 2007 with Ngaire Gallagher and David Mutz have laid the groundwork for cooperative emergency egress from a fire in the Idlewild area across ranch land, if necessary. The agreed principle paths to safety are eastward into the Gallagher pasture from the Northeast Road 12 and 13 areas, and north into the Mutz Ranch where there are dirt roads to the Red River Highway, and of course, along SH 127 to Eagle Nest. We do not have permission to escape west into Taos Pueblo land nor South onto the Gallagher pastures, where there is no viable connection to major roads. These directions would likely be more dangerous than going east and north, since there are no improved roads.

### 3. ROAD IMPROVEMENT

We could put more effort into encouraging the state to widen and improve State Hwy 127 to allow for two way traffic in the event of a wildfire that requires evacuation and the arrival of emergency vehicles.

### 4. FIREWISE PRACTICE

We could make ourselves available for consulting property owners wanting help in planning what to do to make their property more firewise. We could publish what can be done on the Idlewild web site.

We believe that it is possible to organize our community FH&S effort further, but that because of our dwelling density and 1930's NM subdivision heritage, would need to write grants and manage the local forest in a manner appropriate to our heritage and current building situation. As long as we're allowed, the Forest Health and Safety Committee will continue to support these efforts under the auspices of the IWCC Board of Directors.

## Map Committee Update

---

Frank Ray and wife Helen Hyams made the trip to Raton in early August 2010, with the goal of obtaining an updated deed map of the free plats adjoining the JWD subdivision. As property changes hands, the county mapping department updates the deed record information, and we have been able in the past to obtain a PDF (Portable Document Format) image file of their sectional map, which includes our area. The county's data recording schedule is not optimum for Idlewild, but has more to do with its relationship to state government, but for now the assessor's mapping office is the best information set there is for the approximately 65 free plats covered in the IWCC area map.

The practice of publishing scalable maps on the IWCC website has made it possible for more residents to access the information by electronic means, and has reduced the need for marketing hard copy at church meetings. The Map Committee will request that a marketing link be added to the website map display for those wishing to purchase hard copy.

The remaining 2008 maps were delivered to our Caretaker in August to be used in assisting residents as the occasion arises. Mr. Dodge has suggested that the Map Committee consider (1) annual updates to the electronic map files, (2) passing large-format PDF files of these maps to the Webmaster, (3) selling hard copy to residents who need it, and (4) posting large-format mounted maps in the Community Center and Caretaker's Cabin. We will consider further suggestions and/or ideas from the Board of Directors regarding the distribution of map information.

Jim Herman has worked diligently with the Map Committee to maintain a close relationship between the Directory entries and map information. The primary exchange tool used so far is a special (private, restricted) Google Group, where updated files are posted when necessary for use by either Map or Directory Committee members. The experiment of using the Google Group relaxes the need for e-mail transmission restrictions and enhances the security of electronic directory information. We have discussed alternative mechanisms, mainly a more general form of FTP (File Transfer Protocol), and Microsoft group synchronizing software, but are still using the Google Group today.

It is essential that the Directory and Map Committees maintain a close relationship and keep the electronic tools simple to use and straightforward.

The Map Committee will continue the practice of supplying maps of the greater IWCC area at no cost to emergency service providers and the Village of Eagle Nest.

Please, if you have a vicious dog, take care of it. Don't ask the whole community to change just to suit ONE person.



# Annual Meeting Minutes

## IDLEWILD COMMUNITY

### Annual Meeting

July 25, 2010

#### Call to Order and Opening Prayer

Don Woolsey called the meeting to order and opened in prayer. Introduction of current board members.

#### Reading and Approval of Minutes

Carlton McNair moved to approve the 2009 minutes as read and mailed. Lynda Sudduth seconded and the motion carried.

#### Treasurer Report and Budget

A.J. Berens presented the Treasurer's Report. The 2009-10 year netted a budget surplus of \$8,335.33. The general checking account balance is \$40,291.69, and the cd account balance is \$31,714.08 for a total of \$72,005.77. The Caretaker's Cabin Building Fund has a balance of \$10,062.65. A memorial donation of \$15,000 was given in memory of Dorothy Davis by the Jack Davis family who requested it be used for an addition/upgrade to the preacher's cabin.

#### 2010-2011 Proposed Budget

A motion was made by Sue Dorr to approve the 2010-2011 Proposed Budget for approval at the Annual Meeting. Seconded by Earl O'steen. Motion carried.

#### Old Business

**Directory:** Don Woolsey announced that the 2010 Directory is ready to be mailed.

**Roads:** Don Woolsey reported the remainder of the roads were to be completed. The culverts for Road 13 were paid for by Idlewild, but the road itself was paid for by Paul Hamilton. The county designation for their cabin is 51 Road 13.

**Maps:** Frank Ray presented the committee report. The current map is posted on [www.idlewildcommunity.org](http://www.idlewildcommunity.org).

**Forest Health and Safety:** Frank Ray presented the committee report. He was happy to announce the addition of Kala Marsh to the committee. The "Firewise" program has grown significantly in size within Colfax County. Due to the smaller lot size in Idlewild, communication between adjoining landowners is recommended for maintaining fire safety. Further, Colfax County will supply a chipper and operator at no cost, but the timing needs to be coordinated between Idlewild and the county. An evacuation plan is in the works and will be coordinated with the Gallagher and Mutz ranches. It is the intention of the committee to continue asking NMDOT to widen Hwy 127 for the safe passage of emergency vehicles and exiting residents. The dead tree on Road 9 is to be removed.

**Beautification:** Mary Lib Thornhill asked the board to address the incomplete cabin on Road 9 and the abandoned platform on Road 12. Don Woolsey explained that all parties had been contacted, but each lot sits on private property and cannot be touched by Idlewild. Mrs. Thornhill further reported that the committee will be planting flowers around the Caretakers Cabin.

**Worship:** Donna Porter asked that everyone continue to send her

recommendations for the 2011 preacher list.

**Newsletter:** Kathy Michael asked for people to submit more photos of Idlewild families and events. She also encouraged everyone to stay connected through the Facebook page and [www.idlewildcommunity.org](http://www.idlewildcommunity.org).

**Property Rental:** Sue Dorr reported that there was one wedding of a landowner in June, 2010, but no other rentals. There is no cost for use of the Chapel or Community Center for any Idlewild families. The fee is \$50 per facility for non-Idlewild reservations plus any setup charges.

**IWCC History:** Ann Knupp Manta noted that the history is in the printing process. Order requests will be put in the 2010 Fall Newsletter. Price to be determined. **Editors Note:** I checked with Ann and the history is not ready yet.

**OHV:** Don Woolsey asked for everyone using OHVs to review the New Mexico rules and guidelines.

#### New Business

**Davis Memorial:** Donna Porter recommended that an addition of approximately 300 sq ft be made to the preacher's cabin using the current Dorothy Davis Memorial funds and continued fundraising for the remaining amount. It is estimated to cost \$30-35,000.

Mary Lib Thornhill moved to proceed with the plans, bids, and fundraising for an addition to the Preacher's Cabin. Virginia Myers Dorman seconded, and the motion carried.

**Caretaker's Cabin Porches/Entries:** Don Woolsey reported that the work had been completed as contracted and the floors were next to complete.

**Acknowledgements:** Don Woolsey extended his appreciation to several community members.
