President's Letter

To All Idlewilders:

The progress made in the past continued this season. We had a terrific list of preachers for Worship services and attendance was very strong. We started clearing of the property across from the Community Center. Dry weather allowed us to conserve funds allocated for road repair, so we underspent the budget.

Our fire protection efforts were delayed, since we relied on Colfax County to provide their chipper, only to find that they have changed the application rules to our disadvantage. They will only chip on Highway 127. Further, we have to share usage with the County Road Department and other communities. There are other issues as well. The combination of these restrictions makes their chipper of little value.

We have, of necessity, taken the chipping and clearing efforts into our own hands. Frank Dodge purchased a tractor and installed a blade for it that he already had. He can now do some roadwork that we used to contract out. Further, the tractor has a Power Take-Off that can drive the chipper that I purchased. Both of these items are for the sole use of Idlewild. While we are limited in the size of the material we can chip, we can chip on our own roads. The enthusiastic response of cabin owners to the need for thinning and cleanup can be continued with this equipment.

With the approval of the board I wrote to the War Chief of the Pueblo, asking for a meeting to discuss possible joint efforts for firebreaks at property boundaries. We briefly discussed the potential for collaboration in these areas before I formally requested their participation. As yet he has not responded.

After more than a year of requesting a Fire Risk Assessment from the State Forestry Division, three members of the Division completed the job. Their full report is on the Idlewild website and a table with selected results is provided in this newsletter on page 4. A brief scan of the table will show that there are a number of items where we can, over time, substantially lower our score and fire risk. We are addressing the items where our scores and fire risk can be readily reduced.

On September 24th, I made a presentation to the Colfax County Commissioners regarding the need for a much stronger fire protection response for the Moreno Valley communities. The transcript of the presentation is printed on page 5. In the presentation the Commissioners, Fire Marshal, and I discussed a number of items where our fire risk score could be lowered. Fire water storage in Idlewild was one of those items. With the permission of the board, I wrote our Commissioner, Landon Newton, asking that the County grant to Idlewild four lots in Block 129 that we can use for fire water storage. Hopefully, the county will respond favorably to our request.

There were no sales of property this year. Some efforts are under way to consolidate properties, single lots first, as described in this newsletter.

The board and I are making good progress on numerous fronts. We'll continue to evolve efficiently and responsibly to the challenges ahead.

See you on the mountain!

Firewise Risk Assessment Evaluation

On July 24, 2013, three members of the New Mexico State Forestry Division performed a Firewise Community Assessment of Idlewild. The Assessment is designed to provide an effective management approach for preserving wildland living aesthetics. The results of the Assessment can be tailored to a community by identifying vulnerable areas that can be addressed to gain maximum protection from wildland fire. The full report, titled "Idlewild Firewise Community Assessment," is available at idlewildcommunity.org.

The numerical scores for selected categories of the Assessment are provided in the following table. The Idlewild score indicates the maximum risk for us due to wildland fire. Examination of the table indicates that there are areas we can address that will give us the maximum benefit for our efforts, such as water storage, increase in defensible space, and better ingress and egress. We are facing a situation that has arisen over the 80-year history of Idlewild and will not be significantly reduced without much effort over a substantial period of time. Our past efforts were recognized by the assessors during their visit. Continuing them over time will reduce our score and, thus, reduce any potential damage from wildland fire.

STATEMENT OF IDLEWILD COMMUNITY

Since April of this year we have engaged in an aggressive program of clearing slash, fallen trees and other forest detritus from the property of cabin owners. This program has succeeded beyond any expectations held by me or other residents of Idlewild.

The contribution of Colfax County and the CCCFC through the use of the Vermeer chipper was a critical part of what has been accomplished thus far. We are immensely grateful for that cooperation.

The early stage of becoming firewise, as described above, is clearly recognized by our cabin owners. We have received great participation from them and it is increasing. As was anticipated, however, now that some work has been accomplished the true scope of our problem has become clearer. We are obviously engaged in a multi-year effort that requires substantial additional effort beyond picking up slash and fallen trees.

With our current resources, the goal of becoming firewise will take many years. We need, therefore, additional resources to expedite our efforts and keep the existing momentum we have generated with cabin owners. There are two short term requests that we think must be addressed and other long term actions that must be placed on the schedule.

Short term we must have a reliable chipper and schedule. Materials collected cannot be realistically disposed in their collected form. There is just too much volume. Secondly, we need a means to remove deadfall from generally inaccessible areas. Dragging material either uphill or downhill is far too labor intensive and would require too long to accomplish to maintain our current momentum for becoming a firewise community.

As a long term goal we need to become educated regarding defensible space. This effort can be combined with a general review of Idlewild to establish priorities for implementing the needed measures.

We ask the CCCFC to assist us in obtaining the necessary additional resources and assistance in prioritizing our future efforts.



Forest Health, Data Management, and Maps

Forest Health and Safety Committee Report, Frank Ray, Chair

Last fall, I traveled to Raton for a tour of the Track Fire area, and published a summary, after a review by Paul, of germane findings in the Fall 2012 *Idle Times*. With additions from Paul and Frank Dodge, the FHS committee also published an article in the Fall *Idle Times* listing fire prevention points specific to the IWCC area.

With approval from Paul, I teamed up with Raymond Stahl to purchase a durable, adjustable fire danger sign (Raymond's idea). We made an agreement with Frank Dodge to supervise its installation on the SH 127 right-of-way near Trail's End Rd., by a crew from the New Mexico Highway Department, who approved the plan. Installation was accomplished during the winter.

I fielded a request for special maps for the local emergency response (ER) teams from Eagle Nest Volunteer Fire Department Chief Scott Gibson (see the IWCC Map Committee report).

IWCC Data Management Committee, Frank Ray, Co-Chair

This year I modified the FileMaker IWCC database structure to more efficiently serve the needs of Directory and *Idle Times* operations, making more use of cloud storage via Google Drive. I refined the Directory-generation script, automated the PDF assembly procedure, and created a "manual" covering all the details of typesetting the Directory. Frank Dodge, Helen, and I made several editing passes over the database, in support of Jim Herman's Directory production by a printer in Clovis and, with Helen's careful editing, this supported mailings for two *Idle Times* editions, the assessment letter set, and the early-payer free Directory set, using feedback from Treasurer Sparky Eckles. I exported the database, as it was defined on July 9, 2013, to Google Drive, minus scripts and formatted for Excel, and notified the current IWCC data group—the board of directors, webmaster Craig Sutton, Jim Herman, Frank Dodge, Philip Sutton, and Greg Giessner. Mailing feedback from the USPS, via Panhandle Pre-Sort, was received and applied after each mailing. Using that method, in addition to "gleaned" information, the early payers' Directory mailing list (~200 items) had zero error notices.



IWCC Map Committee, Frank Ray, Chair

The committee continued gathering information from Colfax County, Frank Dodge, Jim Herman, and scattered residential reports regarding map and Directory updates. The map changes are targeted for a 2014 printed publication.

Chief Scott Gibson requested thirty 11x17-inch maps on waterproof polymeric media ("Rite-in-the-Rain") for use by ER teams in the field and six 24x36-inch laminated maps to hang in various ER offices, both maps spanning the greater IWCC area, and both including contour lines. I computed the contour lines from Google Earth terrain data using the SketchUp 3D CAD program and applied them to a special edition of the IWCC area map; I printed the field maps at home and took the file to Miller Blueprint in Austin for large-format printing and laminating. The IWCC will not be billed for this, and may consider it a donation to the ER units. All maps were delivered to Scott Gibson in late June.
